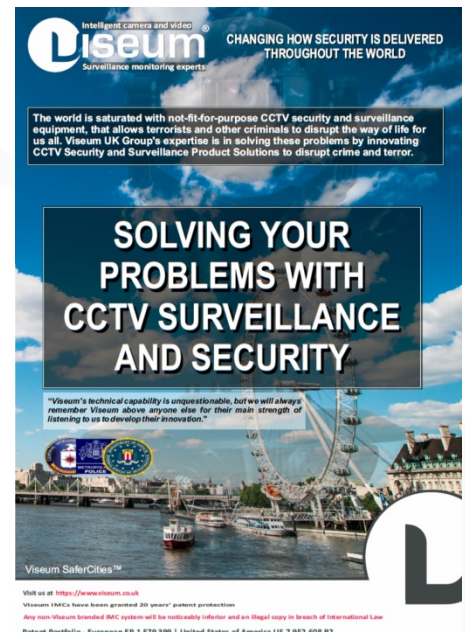


Controlled Subject Testing

'N' number of people and vehicles will be enrolled onto the Viseum Watch List Management System, with their faces, and/or vehicle registration numbers, and social media test accounts if required. These test subjects will circulate amongst non-enrolled vehicles and people. When automatically detected, each subject will be reported and processed using the Viseum Social Media Investigations. A test schedule is then developed to log successful results and with ways to mitigate penetrating the system.
